#### VIRTUAL PROFESSIONAL DEVELOPMENT NETWORK IS BORN

A new electronically-based professional development network, the Virtual Professional Development Network, is about to get off the ground within the Catalyst Grant as a way to assist professors of deaf education with models of best practice in teaching.

The plan calls for several outstanding teachers as a pilot phase to incorporate videoconference equipment in their classrooms. Videorecordings will be made of their teaching, whenever they give approval, and the recordings will then become part of a bank of videorecordings upon which faculty in university departments of deaf education may draw upon to demonstrate those best practices to their classes of pre-service teachers. These same experienced teachers will be offered assistance in using these videotapes and other materials, to develop portfolio's for application for certification from the National Board for Professional Teaching Standards(NBPTS).

David Martin and Harold Johnson are co-leading this network, which has the potential to significantly expand the models of strong teaching as exemplars for future teachers. # UNDERSTANDING BY DESIGN: MEETING THE CHALLENGE

The ACE-DHH pre-conference workshop this year will address the topic of curriculum design in deaf education. The issue is becoming increasingly important with pressure exerted by various constituent groups: state legislators, hearing parents, statewide proficiency test proponents, public school programs, Deaf Community, charter schools, and home-schooling proponents. This workshop also will address how and where to best integrate technology into effective curriculum design.

Presenter: **Dr. John Brown** was one of the original cadres of individuals giving feedback and assistance to the authors of <u>Understanding By Design</u> and their companion training program. He is a nationally known presenter on the book and its implementation. The presentation is funded by OSERS/US Dept of Educ. through the ACE-DHH Catalyst Grant.
