

Sr. Mary Delaney Honorary Life Membership Award

Nominations for the Sr. Mary Delaney Honorary Life Membership Award are being sought by the members of the Awards Committee. A description of the awards and the criteria for eligibility follows:

Minutes from the Business Meeting

ACE-DHH 08 Opening Business Meeting

Thursday, February 22, 2008

Nancy Benham called the meeting to order. She thanked everyone for being there, and welcomed everyone to the 2008 conference. She emphasized that we need to keep on schedule so that the hotel staff will be able to get the rooms ready for all the events. She then introduced Lou Larwood, the Local Arrangements Chair. Lou welcomed everyone to Monterey, and encouraged everyone to take advantage of all that the city has to offer. She thanked everyone for their attendance, and wished them a great conference.

Nancy then introduced President-Elect Deb Stryker. She welcomed the group, saying that we have a full day and we will work hard to keep things on schedule. She announced several changes to the schedule.

Nancy announced that the minutes from last year's conference were in the e-newsletter. Dee moved to approve the minutes. The motion was seconded and passed.

Committee reports:

Local Arrangements-Lou Larwood

Lou had nothing to add. Nancy commended her for doing a great job.

Dee Klein-Newsletter

Dee reported that we have had 3 newsletters go out electronically in pdf format. She asked any members to contact her if they would like to have it in Word. She also said that if anyone was having a problem getting the newsletter, they should let Kate Reynolds know. Dee summarized the content of the newsletters. She reported that she had asked the membership about interest in creating a logo for the organization, but she did not get much response. She will bring it up again to see if there is any interest. She mentioned that one person had volunteered to help her with the newsletters. Dee apologized for getting the last newsletter out late. It contained a memoriam for Frieda Hammermeister, and the final information about the conference. The next newsletter will come out in the spring. Sharon Baker asked if it would be possible to put the newsletters up on the web-site. Nancy said that we could do that.

Treasurer's report-Nancy Benham (for Margaret Finnegan)

Nancy went through the Treasurer's report since Margaret was sick. She reported that the organization has a current balance, prior to the conference, of \$59,000. This year's conference was budgeted at \$40-45,000, but it seems likely that we will come in over budget. We do not yet have an estimate for the interpreters' charges. In addition, we have some other upcoming expenses:

Professional tax preparation	\$500
IASET dues	\$750
CED dues	\$2000
Incorporation fees	\$75

Nancy asked for discussion regarding IASET (International Association of Continuing Education and Training.) She explained that we went through a great deal of time and effort to get approved and trained for the program. When it was first introduced, the membership seemed to see it as a great opportunity to provide online professional education. In our pilot year, 2 presentations were offered. We are approved for 20 years, but we have to pay annual dues, and they are due soon for this year. Nancy reported that very few people are taking part in it, so she asked for some discussion regarding continuation of the program. It was reported that sessions were not very well attended, even though information was sent out about the offerings by email and FAX. Members were asked to contact local agencies that might be interested. Nancy stated that we need to decide if we want to continue because dues need to be paid soon.

Nancy reported that this was all the information Margaret had so far, regarding finances. She repeated that she expected the conference costs to be over budget. Dee stated that funds for the organization are generated primarily through membership dues. Karen Dilka asked if we got any sponsorships for the conference this year; Nancy said we did not. Shirin Antia asked about sponsorship from JDSD, but it was reported that that was for last year only. She also inquired about the agreement between JDSD and ACE-DHH, and wanted to know if we had received any income from subscriptions. No one was able to report on that at this time. A motion was made to accept the Treasurer's report. It was seconded and passed.

Membership/Election Committee-Kate Reynolds

Kate reported that 90 members had preregistered, and an additional 20 had registered at the conference. Some members had registered at the conference, but have not yet paid their membership dues. She reminded everyone that you must be a paid member in order to present at the conference, and this will be enforced. Kate announced that we will be migrating and rebuilding the website, and at that time we will also be rebuilding the membership list.

CED representative's report-Lynn Wolsey

Lynn reported that CED met prior to this conference and voted on accreditation. The results of the vote will be announced at the banquet on Saturday. She said CED is looking to ACE-DHH as the resource in the training of teachers. They are looking at website development and other current needs. She encouraged anyone with questions or ideas to let them know. She reported that CED is revising the manual to be more specific, and working on developing an exemplar for universities to help the accreditation process go more smoothly. She added that they are also looking into how they might be able to accredit 1 person programs so they are not discriminating against them. She said that there is still a crisis for teachers and professors in deaf education, and she urged everyone to contribute any ideas they might have.

Deb Haydon brought up a problem with the list serve. She said that many members have dropped off of it, and urged them to please get back on it since that is the way we communicate about what is going on As an example, she noted that Susan Easterbrooks worked incredibly hard on revisions of the standards, and members were asked for input via

the list-serve. Those who are not on the list-serve, did not get the opportunity to participate in this, and may miss out on a lot of other information and opportunities. Susan Lenihan asked if the group felt that CED should start a separate list-serve that is just program directors. Deb Haydon brought up the idea of having a membership only list-serve. Karen Dilka reiterated the importance of giving feedback about the revisions to the standards as the changes will have a significant effect on us. Lynn asked anyone who did not get a chance to review the revisions to please get in touch with her or with Deb.

Lon Coons said that he had difficulty figuring out how to get on the list-serve. Nancy explained that to join the list-serve you have to go through the website. Kate reported that we are considering building a separate list-serve for ACE-DHH members only. Nancy added that our list-serve is currently run through deafed.net. She reiterated the importance of joining the list-serve so everyone gets access to current updates and information. Anyone having difficulty getting on to the list-serve should go to deafed.net and ask Sherry Ernsberger to help them.

Nancy suggested we continue the discussion regarding IASET. Kate asked if ACE-DHH makes any money when a workshop is presented through the program. Nancy responded that we do not make enough to offset our expenses right now, as there were significant expenses for the start-up. Shirin mentioned that her group has discussed using the site for her doctoral students to make presentations. Susan Easterbrooks reiterated that they saw it as a great opportunity for the doctoral students to do this as a service activity which would link them to ACE-DHH and enhance their connection to the professional community. Sharon Baker noted that her state is desperate to offer professional education opportunities, and suggested that they may be interested in contracting for presentations. Melinda said the same was true in Nebraska, and suggested going to the various state departments of education, and the regional directors. Nancy said she thought this had already been done.

Alan pointed out that we have already invested a great deal of time, effort and money in setting this up, and that we may want to give it some more time to see what develops. Since we have the money to pay the dues, he moved that we pay for the coming year. The motion was seconded.

Claudia asked for more information about what we make, and how many participants we would need to offset our costs; that would give us some criterion to determine if it is frugal to continue.

Kate suggested appointing an ad hoc person to be responsible for overseeing it. Nancy said that was her job. She added that she has sent out a lot of email requests for people to get involved, but has seen very little response. Kate asked about doing a needs assessment; Nancy said it was already done. She added that initially people seemed to be very excited about it, but it has been difficult to get them to make the commitment to really participate. Christine Peragoe asked what format is required for delivery of the presentations. Nancy replied that it is up to the presenter, but 10 hours is the requirement for 1 CEU, and there is a 3 CEU maximum per presentation. She added that we are not allowed to offer courses for university credit. Christine suggested encouraging people who are already offering courses to present some

"repackaged" versions. Sharon encouraged Nancy to contact state departments by phone to see if they may be interested in it. She said they often have money that they are required to disperse for teacher professional development. She offered to check with the Oklahoma Department of Education to see if it could work.

Nancy explained that presenters are paid per participants, and ACE-DHH gets a small % of what is made.

Lynn suggested putting together a flyer about it so that she could bring it to CED and NASDI. The members were reminded that there was a motion on the floor; a vote was taken and the motion to pay the IASET dues for the next year was passed.

Kate Reynolds reported that 2 positions needed to be filled, and that we had 1 "volunteer" running for each position. Sandy Bowen has agreed to run for President-Elect and Jerry Buisson has agreed to run for Treasurer. Nancy thanked them both for volunteering, and added many thanks to Margaret for filling the Treasurer position for so many years. Both Sandy and Jerry were voted in by acclamation. Kate reminded the membership that next year the positions of Secretary and Membership Committee Chair would be open.

Old Business:

A proposal was submitted by Kate Reynolds to hold the 2009 conference in New Orleans. She summarized that there had been a consensus to try to find someplace warm to go. Several sites in Florida had been considered, but room rates were high. One option suggested was to change the time of the conference to just after New Years or to April to see if the rates in Florida would be better. Another option would be to return to New Orleans. Kate reported that the Monteleone Hotel has been recently renovated and they have offered rooms for the week after Mardi Gras (early March) at \$169. Jerry Buisson and Marilyn Sass-Lehr volunteered to help. Kate suggested adding a day to the conference during which time participants would be able to contribute a volunteer day to work on rebuilding homes in the city. She showed a DVD about the Monteleone Other suggestions for conference sites were asked for, but none were offered. A motion was made to hold the 2009 conference in New Orleans during the first week of March. The motion passed.

Nieta Israelite announced that anyone who was interested in getting together to honor Frieda Hammermeister is welcome to join her for dinner tonight. Frieda's death was a big loss to all of us, personally and professionally.

Marge Harrington presented the 2008 Sister Mary Delaney Emeritus Life Membership Award to Dr. John Luckner, program coordinator at the University of Northern Colorado. Dr. Luckner is a prolific author, and presenter and has been involved in university teaching and research for many years.

Nancy moved to adjourn the meeting. The motion was seconded and passed.
